“SchoolWatch” is CPTED in Action: A Crime-Prevention Partnership between School Campuses and Caring Neighbors

Criminals do not want to be observed when they commit a crime. The basic CPTED principle of “natural surveillance” understands this. Now, a new program called *SchoolWatch* asks for organized assistance from residents whose homes or apartments provide “line of sight” opportunities to observe school properties.

Certain campuses within school districts tend to be routinely challenged by street-level crimes such as burglary, grand theft, criminal mischief, and vandalism. Most often, neither school administrators nor the local police are able to stabilize the severity and frequency of attacks against these particular properties.

These high-crime schools tend to have negative environmental factors in their immediate neighborhoods. However, amidst a sometimes bleak background, caring people who want to protect their schools will invariably emerge. The closer these concerned neighbors live to the campus, the more protective they tend to be. They will become a crime fighting resource when they practice basic CPTED. Provide them with organized structure, teach, praise, motivate, and challenge them, and they will respond with impressive crime-prevention results.

SchoolWatch Program Objectives:

- To reduce criminal activity at schools with a history of crime problems
- To offer school districts and administrators a professional crime-prevention solution at a time when they may be frustrated and lack answers

Program Overview:

A school campus is most vulnerable to crimes after-hours. Serious events such as vandalism, burglary, and arson usually occur when the staff has left the campus. A truly comprehensive school security and safety program goes beyond alarm and camera systems. Full-service protection for schools must include “observe and report” participation by nearby residents whose homes or apartments surround a school.

SchoolWatch participants are nearby neighbors who have been trained by a *SchoolWatch* coordinator to recognize and report suspicious campus activities. Routine watching of the campus, coupled with regular communications with school staff, will teach them the difference between normal school events and what is out-of-the-ordinary.

Here’s what makes a good *SchoolWatch* neighbor:

- Their place of residence provides them with good line-of-sight visibility of a school campus.
- They are of good moral character with a clearly-defined sense of right and wrong.

They are somewhat “street smart”; have knowledge of the particular people and activities in their neighborhood.

They have a child who attends or attended the school. (optional)

Resources that need to “buy-in”:

- School PTA leadership
 - Local law enforcement and fire department
- School district security

Steps to Organize:

- Present the *SchoolWatch* program overview to school and/or school district administration and law enforcement. Include “success stories” where an alert nearby resident prevented a crime.
- Provide a marketing plan, which may include door-to-door visits of surrounding residences.
- Create and print a marketing flyer.
- Locate and print the aerial pictures of the campus (available online).

- Set first meeting date and ensure invitations are extended adjoining families.
- Conduct a vulnerability assessment of the campus.
- Analyze campus' prior criminal history through the use grid and police reports from local law enforcement

Optional Additional Resources:

- 24-hr. telephone "hotline" to report suspicious activities and/or criminal intelligence
- A "telephone tree" that logs the phone numbers of the neighboring residences onto an aerial photograph (found on *Google Earth*).

Every community has people that care about the security of their neighborhood schools. Within this group are people who can practice CPTED's *natural surveillance*. Locate, organize, and encourage them and they will become an effective tool to detect and deter campus crime.

Street Closed to Deter Dealers

-A concept used to deter drug dealing around the country will soon be tried on for size in one of Manatee's most crime-ridden areas. Starting next week, the Bermuda 100 neighborhood in southern Manatee will offer only one way in and one way out, with the elimination of one route into the area.

Manatee County commissioners unanimously approved placing temporary barricades on the north side of the intersection of 57th Avenue East and Seventh Street Court East as an experiment to determine its effect on the area's crime rate, according to assistant transportation director Harry Mendenhall.

"After 90 days, we'll check in with the sheriff, who will report if the closure serves as a crime deterrent, and whether we should continue with it or not," Mendenhall said.

The only way in and out of the neighborhood will be at the intersection of 56th Avenue East and Ninth Street East.

By blocking one of routes into the neighborhood, people will have a tougher time committing quick drive-through crimes, such as open-air drug deals and drive-by shootings, according to Maj. Chuck Hagaman of the Manatee County Sheriff's Office.

A complaint from a property owner regarding the neighborhood, which has a long history of drug activity, prompted this attempt at a solution.

"The property owner contacted the sheriff's office about the problem, at which time the agency came forward and suggested this as an idea for reducing criminal activity in the area," Mendenhall said.

The commission approved the road closure, saying that it likely would deter crime, said County Commissioner Ron Getman, whose district includes the Bermuda 100 neighborhood. "We know it contributes to the ease of criminal transactions," he said.

"We're anxious about anything we can do to heighten the amount of safety in a community." If it proves effective, the concept, known as "crime prevention by environmental design," may be tried elsewhere. "It's been highly effective in tackling drug dealing in the past in other communities throughout the country," Hagaman said. Under Florida statutes, if the closure becomes permanent, the county would have to vacate the property, Mendenhall said. Sections of portable, water-filled barricades will be connected at the intersection, in combination with a sign notifying drivers of the road closure. Each of the sections weighs at least 75 pounds and holds 100 gallons of water, creating a nearly 900-pound structure, Mendenhall said.
